### **About CIVIC**

CIVIC, the Caribbean ICT Stakeholders Virtual Community is a regional multistakeholder permanent virtual network of around 300 members comprising individuals from all sectors (Governments, Academy Business, Development cooperation, Civil Society, regional organisations etc.) that have an interest in promoting the use of ICTs in the region. It was created in November 2002, and has been since a very active permanent mechanism of knowledge sharing, carrying out thematic discussions, promoting regional projects and taking Caribbean collective positions in global forums (like a the World Summit on Information Society).

The CIVIC 2.0 event, to be held November 11-14 in Juan Dolio, opens a new stage of CIVIC life. It has 3 main components: (a) a CIVIC consultation process that will identify and elaborate the components of a 2-3 year strategic plan for CIVIC to address the challenges facing ICT for development in the Caribbean (through enhanced capacity for advocacy, knowledge production, ICT4D projects design and evaluation, regional collaborative projects, among others). (b) A Two day training seminar on ICT4D policy, and (c) a one day training workshop in the moderation and facilitation of thematic channel/web sub-groups. This workshop will feature the launch and introduction of the new CIVIC 2.0 platform.

### **About CTU**

The Caribbean Telecommunications Union (CTU) was established in 1989 by the Heads of CARICOM Governments, to rationalize the telecommunications policy framework for the region and to address the problems of regional spectrum frequency incompatibilities. In 2004, recognizing the rapid pace of technological innovation and convergence the CTU expanded its remit to address matters relating to information and communication technologies (ICT). Membership was also expanded to include private sector entities, civil society organizations, academic institutions and non-CARICOM countries in the Caribbean. The Union's present focus is on ICT policy formulation, capacity building and representation of the region at various ICT fora. The CTU has initiated projects to reform and harmonize approaches to spectrum management in the Caribbean also to create a harmonized policy framework for Caribbean Internet Governance. In addition, the CTU is collaborating closely with the International Telecommunication Union on a project to harmonize ICT policies, legislation and regulations in the Caribbean.

CTU has adopted a practice of multi-stakeholder engagement in advancing its work to promote the development of information societies and to ensure that Caribbean citizens derive tangible benefits from the ICT revolution.
